

# Pfizer Independent Medical Education RFP

## Multidisciplinary Team Education in Duchenne Muscular Dystrophy (DMD)

Competitive Grant Program -Pfizer Internal Review Process

#### **Overview**

This competitive grant program seeks to encourage organizations to submit grant applications for mutidisciplinary team educational activities focused on Duchenne Muscular Dystrophy (DMD)

### Geographic Scope

US, Canada, Europe, South Korea, Japan, China, New Zealand, and Australia

#### **Project Types and Area of Interest**

Potential applicants are encouraged to identify and address the educational needs of healthcare professionals in order to address the challenges of multidisciplinary teams and increase awareness of DMD treatment, patient assessment, and monitoring through an evidence-based approach.

## **Key Milestones**

- Application submission deadline: September 26, 2023
- Anticipated decision notification date: November 2023
- Anticipated project start date: on or after December 1, 2023

## **Funding Range**

Individual projects requesting up to \$250,000 will be considered. Pfizer anticipates awarding up to 3 projects.



## I. Eligibility

#### Geographic Scope:

- US, Canada, Europe, South Korea, Japan, China, New Zealand, and Australia
- Proposals may be for a single country, a single region, or for a global effort including all countries of interest.

#### Applicant Eligibility Criteria

- Only organizations are eligible to receive grants, not individuals or medical practice groups.
- The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. All institutions must have a relevant role and the requesting organization must have a key role in the project.
- Requesting organization must be legally able to receive award funding directly from Pfizer Inc. We strongly recommend that applicants confirm this with their organization or institution prior to submitting an application. Grants awarded to organizations that are subsequently found to be unable to accept funding directly from Pfizer Inc. may be subject to rescission.
- For projects offering continuing education credit, the requesting organization must be accredited.

## **II. Requirements**

#### Clinical Area

Duchenne Muscular Dystrophy (DMD)

#### General Area of Interest for this RFP:

Projects that will be considered for Pfizer support will focus on:

- Improving the medical and scientific understanding of DMD to help upskill and optimize multidisciplinary teams for the referral, diagnosis, treatment, and management of eligible patients
- Addressing the holistic challenges that DMD presents to multidisciplinary teams
- Addressing challenges in managing, monitoring, and caring for patients throughout their patient
  journey during an era of increased telehealth utilization and digital initiatives, including continuity of
  care, appropriate diagnoses, and support for patient referrals
- Addressing the need for upskilling of both treatment and referral centers to ensure standardization of patient treatment, continuity of care, and follow-up
- Identifying and addressing barriers that contribute to geographic, gender, and racial healthcare disparities disproportionately impacting patients with a rare disease in order to increase earlier diagnosis and treatment

It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.



#### **Target Audience**

 Members of established multidisciplinary care teams for DMD including, but not limited to, pharmacists, specialty nurses, genetic counsellors, medical geneticists, and other physicians

#### Expected Approximate Monetary Range of Grant Applications:

- Individual projects requesting up to \$250,000 will be considered. Pfizer anticipates awarding up to 3 projects.
- Award amounts include direct costs, institutional overhead costs (capped at 28% per Pfizer policy), and indirect costs.

- Anticipated Grant Award Notification Date: November 2023
- Grants will be distributed following a fully executed agreement.

#### Review and Approval Process

 Grant requests received in response to a general RFP are reviewed by Pfizer to make final grant decisions.

#### About Pfizer Global Medical Grants

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.

## **General RFP Submission Requirements**

Applications will be accepted via the online portal listed in the How to Submit section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

#### Goals and Objectives

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

#### Needs Assessment for the Project

• Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

#### Target Audience

Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit
from the project outcomes. Describe the overall population size as well as the size of your sample
population.

#### Project Design and Methods

- Describe the planned project, the educational approach, and the way the planned methods address the established need.
- Please describe how your proposal and/or your team seek to promote diversity, equity, and inclusion in this project.

#### **Innovation**

• Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

#### **Evaluation and Outcomes**

• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.

#### Dissemination Plan

 Describe how the project may have extended benefit beyond the grant. Will the teaching materials be made available to others to use? Will there be tools or resources that are made publicly available beyond the initial project. Describe how the project outcomes might be broadly disseminated.
